Attention

The notification on the provision of child care is submitted by the applicant or recipient to the application for child allowance and child allowance supplement. The notification on the provision of child care must be delivered to the Office of Labour, Social Affairs and Family, Department of Social Affairs and Family, which is competent according to the place of permanent residence of the entitled person.

In part C, the entitled person shall complete the appropriate part according to who provides child care – institution, legal entity, natural person providing it on the basis of a trade license or natural person (e.g. parent, grandparent) providing it without a trade license.

After the dependent child reaches three years of age, the **entitled person is obliged** to notify the payer in writing or by electronic means with a guaranteed electronic signature, how and where care will be provided for this dependent child until the beginning of compulsory school attendance, during the entitlement to the allowance and supplement to the allowance;

In the event of a significant change in the method and place of child care provision compared to the declared method and place of child care provision, e.g. change of the provider of the institution, the **entitled person is obliged** to notify the payer of the child allowance and the supplement to the child allowance in writing of this change within eight days.

The reporting obligation does not apply to

a parent of a dependent child or a person to whom a dependent child is entrusted to foster parental care on the basis of a court decision and who, in addition to caring for the child, receives **maternity or parental allowance**.
